**A RESOLUTION TO ESTABLISH A RESIDENTIAL SPEED CONTROL PROGRAM BY AMENDING TITLE 10 - VEHICLES AND TRAFFIC OF THE OFFICIAL CODE OF HALL COUNTY, GEORGIA**

**A RESOLUTION TO AMEND TITLE 10 ENTITLED "VEHICLES AND TRAFFIC" OF THE OFFICIAL CODE OF HALL COUNTY, GEORGIA, BY CREATING CHAPTER 10.92 TO BE ENTITLED "RESIDENTIAL SPEED CONTROL PROGRAM" FOR THE PURPOSE OF INVESTIGATING AND INSTALLATION OF SPEED TABLES IN RESIDENTIAL SUBDIVISIONS; TO PROVIDE FOR AN EFFECTIVE DATE FOR SAID RESOLUTION; TO REPEAL CONFLICTING ORDINANCES AND RESOLUTIONS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Board of Commissioners of Hall County adopted by resolution on June 27, 1996, to become effective July 1, 1996, the codification of Resolutions, General Resolutions and Ordinances passed by the Board of Commissioners of Hall County as "The Official Code of Hall County, Georgia" 1996 edition published by Municipal Code Corporation; and further provided for the adoption and incorporation of any Resolution, General Resolution or Ordinance passed subsequent to July 1, 1996, to automatically become a part of The Official Code of Hall County, Georgia; and

**WHEREAS**, the Board of Commissioners of Hall County desires to amend Title 10 Entitled "Vehicles And Traffic " Of The Official Code Of Hall County, Georgia, By Creating Chapter 10.92 To Be Entitled "Residential Speed Control Program";

**WHEREAS**, a public hearing has been conducted with regard to the aforesaid amendment; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of Hall County as follows:

Chapter 10.92 of Title 10 of the Official Code of Hall County, Georgia entitled

“Vehicles and Traffic” is hereby adopted for the purpose of investigating and installing of speed tables in residential subdivisions to establish the evaluation and design criteria pertaining to speed tables.

Chapter 10.92 entitled “Residential Speed Control Program” of Title 10 of the Official Code of Hall County is hereby codified in the Official Code of Hall County, Georgia as set forth in Exhibit A, a copy of which is attached hereto and made a part hereof as if Exhibit A were originally set forth in this Resolution.

If any paragraph, sub-paragraph, sentence, clause, phrase, or any portion of this Resolution shall be declared invalid or unconstitutional by any court of competent jurisdiction or if the provisions of any part of this Resolution as applied to any particular situation or set of circumstances shall be declared invalid or unconstitutional, such invalidity shall not be construed to affect the portions of this Resolution not so held to be invalid. It is hereby declared to be the intent of the Board of Commissioners to provide for separable and divisible parts, and it does hereby adopt any and all parts hereof as may not be held invalid for any reason.
