- 1 Gainesville-Hall Development Authority appointment to serve a term from April 1, 2021 to March 31, 2025. Commission Districts 1, 2, 3, and 4.

- 2 Ratification and Approval for the Chairman to execute a Resolution providing a supplemental objection to the annexation by the City of Buford of Tax Parcel Number 08150 002018 owned by Darryl Crow Holdings LLC located on McEver Road, and authorize the Chairman to execute any and all documents in relation to such objection, and authorization for the Chairman to execute any and all documents necessary to terminate the dispute resolution process associated with the withdrawal of the annexation application as a result of the objection, subject to review and approval by the County Attorney.

Proposed Use: storage yard - truck parking. Commission District 1.
- 8 Application of Gavin Passmore for a Use Subject to County Commission approval on a 3.52± acre tract located on the north side of Old Cornelia Highway at its intersection with Oconee Circle; a.k.a. 2415 C Old Cornelia Highway; Zoned H-B; Tax Parcel 15021B000008.
